The schedule of programme for the proposed election is given below:

- Last date of receiving nomination :19-02-2022(upto4.00 PM)
  - Date of sending the valid Nominations to the HQ for scrutiny:21.02.2022
  - Receiving the Valid list from IOV HQ :23-02-2022
  - Last date of withdrawal of Nomination :27.02.2022
  - Uploading the Final Contestants List on Official IOV Website:28.02.2022
  - Date of Election/Voting on the Day of AGM :06.03.2022 (10 AM to 2.00 PM)
- ✚ As per Bye-Laws, only life corporate members can contest Election for Office Bearers and Membership of the EC of Institution of Valuers, Bangalore Branch for the years 2022,2023 & 2024.
- ✚ For the post of Chairman, Secretary and Treasurer, the candidates must have completed 3 years of life membership as on 31.03.2021 and in the case of contestants for Members of Executive Committee must fulfill the condition of life membership as on 31-03-2021.
- ✚ One corporate member shall be eligible to nominate one life corporate member for one post only.
- ✚ One corporate member shall be eligible to contest for one post only.
- ✚ Corporate members of the Institution, who are in arrears of subscription up to 31.03.2021, will not be eligible to nominate any life member for the election.
- ✚ Licentiate member is neither eligible to contest election for any post nor can vote to elect office bearers and Executive Committee members.
- ✚ Corporate member who is a member of the Executive Committee/Council of any other organization/ Institution/body of valuers in India running parallel activities to Institution of Valuers or holding the post of office bearer of any branch of such organization/ Institution/body of valuers in India, shall not be eligible to contest in the Executive Committee.
- ✚ Members retiring from the EC shall be eligible for re-election.
- ✚ Any error, illegibility, overwriting, ambiguity, absence of fact etc. in the nomination form may lead to rejection of the nomination.
- ✚ In case any dispute the decision of the Election Officer alongwith the Board of Scrutineers shall be final and binding.
